3.2 Objectives:

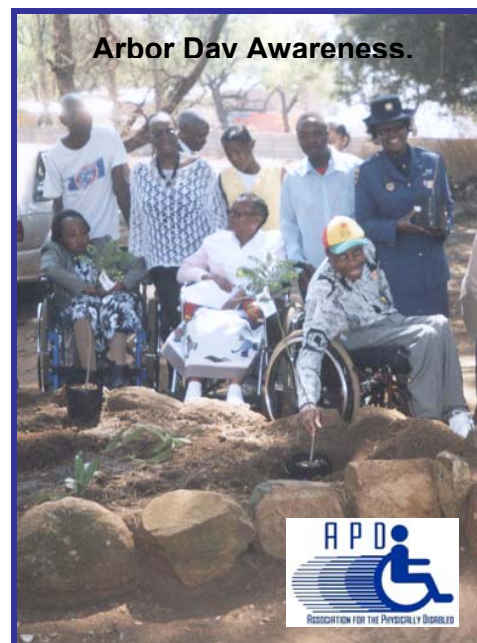
1. To conduct comprehensive assessments and render holistic services to people with disabilities and their families/support systems.
2. To reduce the poverty levels of people with disabilities by empowering them to establish and maintain income-generation projects as per need.



3. To facilitate educational and awareness programmes on disability issues and human rights.
4. To promote the self-development of women, youth, children and people with disabilities via life-skills programmes in a rehabilitative environment.
5. To establish and develop a governing board drawn from the local community to facilitate the administration of each sub-office.
6. To promote an effective networking/lobbying system on disability issues and human rights.
7. To fundraise to ensure the sustainability of the social work programmes.
